This agreement represents the terms and conditions under which LovelyCamGirlsLive.com ("LCGL") shall serve as a service provider to the above applicant.

### **LCGL is a Service Provider**

LCGL serves as an "all-in-one" service provider for internet webcam providers. Specifically we provide website creation and hosting, live video streaming, live chat, and billing services.

Broadcasters are not directly billed for these services. Cost of services is withheld from payments issued to broadcasters. You remain your own boss in that we do not set any terms or conditions on when or how you use (or don't use) our services. **Your relationship with LCGL in no way represents an employee/employer relationship, or that of an independent contractor, you are a customer of our services.**

### **E-Commerce Services**

LCGL will collect fees paid by members of LCGL for services rendered by broadcasters. These fees will then be paid to broadcasters under the terms of our Broadcaster Payment Guidelines. Payment Guidelines, including the timeline for payments and the percentage payout, may change from time to time. You will be notified in advance to any change in our payment terms.

LCGL reserves the right to deduct from Broadcaster's account any fees associated with credit card chargebacks or other fees imposed by our payment processing provider if such fees result from problems associated with the broadcaster's behavior on our site.

### **Streaming Video**

LCGL has a custom developed video broadcasting solution, and as part of this agreement licenses broadcaster to use this software for the sole purpose of audio/video broadcasting on LCGL's site. LCGL's software may not be used for any other purpose.

*Our software currently requires that you have a "web browser", preferably Internet Explorer 6, Internet Explorer 7, or Mozilla Firefox, with the latest edition of Flash Player installed.*

### **Rules and Regulations**

Broadcaster agrees to abide by our *Rules and Regulations* at all times while broadcasting. The rules and regulations are subject to change by us at any time, and you will be notified of any changes.

- You are a customer of the services provided by LCGL, and not an employee or independent contractor. LCGL does not regulate how, where, or when you may use our services, and only

requires that your broadcast content remains lawful.

- All persons who broadcast with LCGL must be at least 18 years of age, or the age required by broadcaster's local laws, whichever is *higher*. Proof of age will be required before an account is available for use.
- "Free Areas" of the site, that is areas where clients do not need to spend credits to visit, may not contain nudity. Nudity may only be provided in paid, age-verified parts of the site.
- No obscenity. Your broadcast, and any images or text associated with your account, may not contain content which violates obscenity laws. Obscenity includes conduct, **either real or simulated**, involving child pornography (sexual activity, nudity, etc with any person under 18); incest; nonconsensual sexual contact (rape) or otherwise coerced sexual conduct, bestiality (sex with animals); necrophilia (sex with deceased bodies); bondage which includes penetration.
- All communication must occur on LCGL's site. Broadcasters are not allowed to exchange email addresses, instant messenger ID's, etc with others members of the site.
- Broadcaster's content may not violate any copyright, patent, or trademark.
- Broadcaster must not slander, libel, or defame any person (living or dead).
- Broadcaster may not interfere with the business operations of LCGL, which includes making disparaging remarks about LCGL or its staff.
- **No person who has not completed all the required documentation (model release, model contract, 2257, etc) and been approved by LCGL may appear in any broadcast.**
- Violation of any of the terms, or any terms outlined in future updates to our rules, will result in immediate termination of this agreement.

## **Limitation of Liability**

LCGL shall not be liable to any broadcaster for loss of profits, loss of business, loss of use, loss of data, interruption of business, cost of procurement of substitute goods and services, or for any special, consequential, exemplary or incidental damages, arising out of or related to this agreement, however caused, and whether arising under contract, tort, or any other theory of liability.
